Dear Mr Neild

I am writing to confirm that we have now completed our search for the information, which you requested on 27 September – copy attached for ease of reference.

A copy of the information is below

1. Have you been approached as to the provision of south-facing slip roads? We are aware of Sefton Council's plans but we have not been approached in regards of provision of any slip roads. We would expect Sefton Council to approach us later this year or next year.
2. If so, have you given approval? No approval has been sought or given. Any work that is directly on the Motorway Network would have to have Highways England approval.
3. If so, has the site developer been asked to make a financial contribution to the cost of building these slip roads? At this time we cannot comment on this as no provisions have yet been submitted.
