- (i) Passports will be issued for a six month period, after which proof of continuing eligibility must be presented, at which time the passport will be renewed, except for Senior Citizens and Registered Disabled Persons.
- (ii) No holder of the Passport will be granted admission without first presenting the Passport to the appropriate reception desk.
- (iii) The Passport must be surrendered for amendment if you, or anyone on it, is no longer eligible to use it, or if your circumstances change in any way.
- (iv) Misuse of the Passport or the facilities will result in withdrawal of the Passport.
- (v) The Council reserves the right to amend the scheme as and when required. Revisions may include, amongst other things, changes to the discounts available and qualification criteria.
