#### 1468. REFORMATTING OF THE 1999/2000 REVENUE BUDGET

Further to Minute No. 1422 of the Policy and Resources Committee of 23rd February, 1999, the Committee considered the joint report of the Finance Director and the Technical Services Director setting out guidance in respect of budgeted expenditure, budget reformatting and virement. Details of this Committee's Revenue budget and service developments referred to the budget process during the year and identified by the Technical Services Director, together with suggestions for reformatting the 1999/2000 Revenue budget, were attached to the report.

<u>RESOLVED</u>:- (i) That the 1999/2000 base budget as set out in Annexes A and B, the Technical Services Director's proposals for growth as set out in Annexe C and the addition of a further £5,000 for street seating and £10,000 for safer routes to schools from the unallocated inflation provision be approved;

(ii) that the Policy and Resources Committee be requested to agree to reserve the additional forecast income referred to in paragraph 6.2 of the report to contribute to the cost of local authority parking enforcement in 1999/2000.

#### 1470. TRANSPORTATION CAPITAL PROGRAMME, 1999/2000

Further to Minute No. 1187 of 11th January, 1999, the Committee considered the report of the Technical Services Director on a proposed programme of schemes in the 1999/2000 Transportation Capital Programme for Minor Works, Local Safety Schemes, Structural Maintenance of Principal Road Carriageways and Bridge Assessment and Strengthening.

<u>RESOLVED</u>:- (i) That the proposals for schemes within the Transportation Capital Programme 1999/2000 for Minor Works, Local Safety Schemes, Structural Maintenance of Principal Road Carriageways and Bridge Assessment and Strengthening set out in the report, within the budget allocations of £1,220,000, £254,000, £192,000 and £640,000 respectively, be approved, subject to them being approved during the budget process;

(ii) that the Transportation (Standing) Sub-Committee be authorised to approve scheme details and budget allocations within the programmes identified in the report.

#### 1471. SEFTON'S HEALTH IMPROVEMENT PROGRAMME, 1999-2002

Further to Minute No. 1355 of the Policy and Resources Committee of 2nd February, 1999, the Committee considered the report of the Chief Executive presenting the draft Sefton Health Improvement Programme (HImP) for 1999-2002. The report outlined the background to the concept of HImP's; the involvement of local authorities as key partners in the process; the development of Sefton's first HImP; and progress with the Merseyside Health Action Zone (MHAZ) bid.
