1. Introduction

Purpose of document

Original UDP Policy Maps

 - II. Maghull (now Sefton East Parishes in Sefton Local Plan 2015)
 - III. Formby




Site MN 8.1 Land at Lambshear Lane, Lydiate




Site HC5.1 Land north east of Red Rose Traveller Park, Broad Lane, Formby




