## Analysis of NLUD and other 'brownfield' sites in Sefton

The tables below provide an analysis of the 232 sites submitted to the Sefton Local Plan Examination by Mr P Neild. The majority of these sites were taken from Sefton's 2011 NLUD return.

Of these sites, the vast majority are either:

- Proposed for allocation in the Local Plan;
- Already accounted for in the 2015 'Strategic Housing Land Availability Assessment' (SHLAA);
- Are not suitable for residential development (for the reasons set out in the table below); or
- Have been developed out since 2011.

Only 2 sites are considered to be potential additional sites that could be added to the SHLAA. These sites have an approximate combined capacity of 11 dwellings (based on the previous planning permissions – now expired).

Further detail is provided in the tables below, including a commentary for each of the 232 sites.
