Updates to Guidance

We have been notified that this week there has been updates to the 'How to Work Safely in Care Home Guidance' (updated 15th June)

https://www.gov.uk/government/publications/covid-19-how-to-work-safely-in-care-homes, which includes updates to the PPE Guidance

The guidance includes:

- PPE recommendations for care home staff
- frequently asked questions on the use of PPE in care homes
- examples which help to identify the correct use of PPE when undertaking
 activities that require physical contact or activities which do not require
 physical contact but are carried out in close proximity to residents
- guide to putting on PPE for care homes
- guide to taking off PPE for care homes

These instruction sheets should be used alongside the video guide to putting on and taking off PPE – a guide for care homes.

PPE Portal Order Limits

After considering the stock and demand levels of customers invited to the PPE Portal, DHSC have doubled the order limits for Type IIR masks on the portal. Healthcare providers on the portal had reported to be the most in need of more Type IIR masks compared to what was previously provided by the portal.

The order limits have been adjusted as of 15/06/20 to the following:

GPs can order:

One combined pack, containing 100 (previously 50) IIR masks, 200 aprons and 400 gloves (200 pairs), per week or up to this amount of separate items

Small social care providers can order:

One combined pack, containing 200 (previously 100) IIR masks, 400 aprons and 800 gloves (400 pairs), per week or up to this amount of separate items

We are communicating this out to all invited customers of the portal, via an email to their CQC/MHRA registered email account.

NHS Net Account

Requesting additional accounts:

If you require additional accounts, you can request these with NH mail via your shared mailbox, as the fast track form only allows you to set up accounts for two named people initially.

You will need to send an email to: careadmin@nhs.net from your shared mailbox and in the body of the email (not as an attachment) state the reason you require additional accounts and provide the name, current email address and mobile number of the person/people requiring the account/s.

An organisation can have up to a total of 10 individual user accounts and one shared mailbox.

Account set up and log in support:

Welcome Email: The welcome email is only sent to the first person named on your original application form and contains information on setting up your accounts. This includes your two individual email addresses, as well as the shared email address. The emails are sent by NHSmail from an automated system so can sometimes go straight into your junk mail, so can be easily missed. The email will be from: care.mailer@nhs.net and the subject of the email will read: **Welcome to NHSmail - Please Read.**
