Dear Care and Community Support Provider,

First, we would like to express that colleagues in the health and care system really appreciate all the work being undertaken by you and your staff to help keep our vulnerable people safe and well.

Please continue to follow IPC guidance, ensuring that your staff wear the appropriate PPE at work. We would also like to ask you to consider your arrangements for the laundry of uniforms; to help prevent staff going to and from work wearing their uniform, to avoid any unnecessary transmission. Although some staff and residents have been vaccinated, it is important to not be complacent as COVID is still prevalent and transmissible.

We would also like to hear any ideas you have on how staff can reduce their use of public transport for getting to and from work and whilst carrying their work. We have heard from some providers that they have purchased bikes to use and some providers are now part of the cycle to work scheme. ### Workforce Capacity Grant Fund

Payments have started to go out this week from the Workforce Capacity Grant fund to care homes and Community Providers who have a CQC registered location in Sefton and is based on £100 per worker (as per capacity tracker information previously completed). Payment of the grant will be considered based on Provider's acceptance of the grant and its terms and conditions. The grant must be spent by 31st March 21 and areas of spend and a proposed return for expenditure and outputs is attached for your information. Please note that there is no specific acceptance letter that they have to sign / return.

### Information for Care Homes

As mentioned on the strategic care home call this week, there is new government guidance for agency staff. The guidance includes:

- Where there is an individual being deployed, they should have a polymerase chain reaction (PCR) test for COVID-19 in the 7 days before starting the placement and have received a negative result.
- The individual should also be tested using an LFD provided by the National Testing Programme on their first day before their first shift.
- Where a provider deploys an individual, who is working in another setting, to help manage the risk of infection the individual should also be tested using an LFD immediately before the shift every time they return to the care home after working elsewhere.

As you will be aware the Government announced that from the 8<sup>th</sup> March residents are to be allowed <u>one visitor per resident Government announcement</u>. Please note that we are still waiting formal guidance on the single-named visitor scheme and we will share this with you as we receive it. In the meantime, you may wish to review your risk assessments and environments in readiness. Please can we ask that you read the guidance carefully on Monday, review it and amend their your own Risk Assessment and visiting policy, if you would like IPC advice and support please e mail public.health@sefton.gov.uk .
