We wanted to remind you that the Mental Health at Work eLearning is now available on Me Learning! The purpose of the survey was to hear from local people and understand their views of the COVID-19 vaccine and whether there is any hesitancy in getting vaccinated. Liverpool City Region Care Providers' Grant

As a direct response to the challenges these businesses are facing, a new fund, the LCR Care Providers' Grant, has been created by the Liverpool City Region Combined Authority.

Care homes have been sent information on this grant and an initial "window" is open for receipt of applications for the Liverpool City Region Care Providers' Grant from Tuesday 4th May 2021 and CLOSE on Tuesday 18th May 2021

Registered Care Homes (Adults) are eligible to apply for the grant and can apply via this link - https://forms.sefton.gov.uk/lcrcareprovgrant/

Workforce Capacity Grant

The returns to show expenditure and outputs for the grant period mid Jan – 31 March were due in on 4th May. Approximately 25% have been returned. Many thanks to those who have submitted their returns and a plea for all **outstanding forms to be in by Monday 10th May**. The return to be submitted is attached – please ensure you are using this return & not the draft that was circulated prior to DHSC confirming what was required. Where returns are not submitted, the terms of the grant request that monies are returned, and we will be in touch about this.

Infection Control Rd 2 / Rapid Test

Thanks to all providers who submitted their final returns to allow us to process a return to DHSC by 30th April. Unfortunately, there are still some providers who have not sent returns and we will be in touch as if the grant has not been spent / evidenced then it may need to be recouped.

Infection Control / Rapid Test 2021

We have had several Annex A's (acceptance of grant conditions) returned and will be sending out grant to those respondents however a cross check will be undertaken and if there are outstanding issues with previous grant returns this may result in a delay to some providers.

A template for April spend is attached and is in a familiar, yet improved, template with allocations which auto populate as the provider is chosen. This information is in the public domain i.e. Gov.uk website for Sefton allocation & CQC website for bed / user numbers. There are separate returns for Care Homes and Community Providers. **The return date for this is 14 May.**

Information for Care Homes

We have heard this week that no homes across Sefton have reported an outbreak, which is fantastic news and testament to all the hard work undertaken by you and your teams –







congratulations!

We are still getting requests from staff who wish to have the vaccine and thank you for your ongoing support with this. We just wanted to let you know that from the 5th May, the Department of Health and Social Care (DHSC) will begin Phase 2 of the Driving Uptake Project, a project to offer direct support via phone calls to care home managers in Older Adult Care homes showing 25-50% staff vaccination rates. This project complements existing work in Local Authorities and NHSE to support social care workers to get vaccinated and, where necessary, triggers additional activities or action plans with the home to improve its uptake. This will also improve future policy making.

Upcoming Proxy Ordering Webinar on 8 June by NHSEI.

This webinar is essentially for homes to understand how to do the proxy ordering and make use of the IT/digital elements. This practical webinar will show how the IT works and feedback from a care home whom is already doing proxy ordering. (Proxy access was developed to allow someone other than the patient to access and manage parts of their GP online services, meaning that care home staff can order repeat prescriptions for patients and include notes to the GP etc).
