A new 'one stop shop' online mental health platform has been launched this week to help children, young people, parents and professionals to make referrals into partnership mental health services in Liverpool and Sefton. Alder Hey's innovation team have worked closely with service users; children and young people & their families and mental health providers to develop the Sefton and Liverpool CAMHS platform that makes accessing the right mental health services much easier.

We would also like to remind you that the return date for the Infection Control / Rapid Test 2021 is the **14th May.** A template for April spend was sent out with the letter last week and the template is auto populated as the provider is chosen. This information is in the public domain i.e. Gov.uk website for Sefton allocation & CQC website for bed / user numbers.

The initial window for the Liverpool City Region Care Providers' Grant closes next Tuesday – the 18th May. Registered Care Homes (Adults) are eligible to apply for the grant and can apply via this link - <u>https://forms.sefton.gov.uk/lcrcareprovgrant/</u>

The national booking service for health and social care workers has now reopened. Following JCVI guidance released on 7th May which stated that under 40s should be offered alternatives to AZ vaccine, the self-referral route in the National Booking Service for Health and social care workers was suspended to prevent any further under 40s from booking appointments which may result in the AZ vaccine being offered. The issue has now been resolved and the National Booking Service has been amended to allow people to book onto specific vaccine appointments.

Please continue to promote the vaccine with your staff and please encourage them to have their second dose to increase their protection. COVID-19 Testing

Local coronavirus testing **for people without symptoms** is being introduced in Sefton's Formby area in response to recent COVID-19 outbreaks, which showed cases of the variant first identified in India. Starting from Friday 14th May, mobile, drive-through test centres will be set up at Deansgate Lane Park in Formby (L37 3LF) and at Ainsdale Hope on Sandringham Road (PR8 2PJ), and there will be a walk-through test centre at Sefton Professional Development Centre (PDC) on Park Lane (L37 6EW).

The opening times are as follows:

- The Deansgate drive-through test centre will be open from 9.00am to 4.00pm Monday to Friday, The PDC on Park Lane will be open between 9.00am and 4.00pm seven days a week.
- The test centre at Ainsdale will be open from 9.00am until 4.00pm on Friday 14th May, but from Saturday 15th May will be open 9am to 8pm seven days a week.







Appointments are not needed for tests at any of these centres.

Sefton Council's Public Health team are also finalising locations for smaller, pop-up test sites in the community.

Sefton Council is moving its RAPID coronavirus testing centre for people with no symptoms from Bootle Leisure Centre to Bootle's Strand shopping centre. From 9am on Saturday 15th May, people without COVID-19 symptoms will be able to get a test, with a result in as little as 30 minutes, at the town centre location. The former H Samuel unit in the Strand, has been specially adapted for people to come along and take a RAPID test safely. It will be open seven days a week.

Information for Care Homes

The DHSC are organising a series of webinars on whole care home testing. There are changes to the registration of LFT and PCR registration for care homes due to the volume of testing undertaken in these settings. Important things to note:

- These changes to the system go live on 20th May.
- 119 to contact if there are issues, as it is not part of local authority responsibility.
- LFT results if they are positive/negative / void can be added.
- The spreadsheet is same as before
- No changes to staff or visitor testing this must still be adhered to by all settings

Dates for the sessions are 17th &19th May – it is advisable for all care homes to register and attend these sessions. Please note care homes must register in advance by clicking on this link: <u>https://event.webcasts.com/viewer/portal.jsp?ei=1369434&tp_key=296e54cdc9</u>

All care homes across the country are being required to change their ordering process from paper to electronic, to facilitate this Proxy access to residents' medical records is required. This is an NHS England project and many care homes have already changed to electronic ordering, the benefits are as follows:

- fewer risks and issues associated with ordering, issuing, collecting, and dispensing repeat medications
- fewer errors and queries (e.g. missing items, what has been ordered/collected from pharmacy)
- improved clinical safety
- easier and faster access, as care home staff can order at any time of the day or night
- an improved, easy to access audit trail
- improved data security due to care home staff have their own username and password, which also saves time







• better communications and working relationships between all

Sefton Medicines management team are happy to support care homes with this and are contacting homes to discuss how this can be moved forward. In appreciation of the work undertaken to support this change there will be a financial incentive. We are just in the process of arranging this. Please note this will also be given to homes that have already changed to electronic ordering.

We just wanted to let you know that revised PPE guidance for care homes is expected soon. To accompany this, there will be a webinar as below:
