### **Your Decision**

We have sent you this letter to tell you how much Housing Benefit and/or Council Tax Reduction you are entitled to. This letter also tells you the reason for the calculation.

Please check the decision notice carefully to make sure we have used the correct information to work out your entitlement.

Your entitlement is granted on the following conditions:

- That the information given on the application form or any additional correspondence about income and circumstances of the claimant, their partner and everyone who lives in their home is true and complete
- That entitlement is based on the income, capital, family, household and non-dependants shown in this letter. If any details are incorrect you must advise the Benefits Service straightaway.

### **Change in Circumstance**

You must tell us of any change in circumstances that could affect your entitlement. To report a change please visit <a href="https://www.sefton.gov.uk/benefits/apply">https://www.sefton.gov.uk/benefits/apply</a> If you are not sure if it affects your entitlement, then tell the Benefits Service anyway. To prevent losing entitlement or being paid too much, you must tell us about your change in circumstances within **one calendar month** of the date of change. If you are overpaid, any overpayment may be recovered from you. The Council has the right to recover any amount of Housing Benefit or Council Tax Reduction if it is found to have been granted on incorrect or insufficient information, or if the Council has not been told of a relevant change in circumstances.

You cannot get Housing Benefit if you have capital of more than £16,000. You cannot get Council Tax Reduction if you have capital of more than £6,000 (£16,000 for Pension age claimants).

# If you think this decision notice is wrong, contact us within 1 calendar month of the date of this letter and you can either;

- Ask for an explanation
- · Ask us to look again at the decision

If the decision can be changed we will send you a new decision. If we feel unable to change the original decision we will tell you why and how to make a further appeal to an independent tribunal.
