- Community Support and Direct Payment (Agency) rates are currently aligned to the 'main' Domiciliary Care hourly rate
- The Sleep-in rate above is based on the new National Living Wage of £9.50 plus 15% on costs (I.E. £9.50 + 15% x 8 hours)

- Development of Extra Care is a key strategic objective
- Council currently implementing future commissioning / procurement arrangements for Supported Living
- Supported Living is also key element of current demand management, transformation, technology and housing strategy work – in order to ensure sustainable and quality provision
- People with learning disabilities will be supported to be as independent as
 possible and tailored to individual need. Primary consideration is for people to
 be offered excellent care at home supported within their own communities.
 The ambition will be to support people who need care and support to achieve
 their outcomes and offer greater housing and care choices either as a shortterm measure or long-term support.
- Also wider work will be conducted as part of "People at the Heart of Care: adult social care reform" Policy Paper
